Extract from the CMAC rule book Page 6 par.15

Welfare of Children and Vulnerable Adults.

Children under the age of 18 years **MUST** be accompanied by a parent, guardian or, for instance, someone who has written authority to bring the child on to flying site and supervise them.

Junior members under the age of 14 years shall not start an engine or carry a model with the engine running unless they are supervised by a responsible adult.

No senior member is to be expected to assume responsibility for a child or a vulnerable adult unless he/she has been specifically requested to do so by the parent, guardian or carer.

If required to do so, he/she is to assume complete and total responsibility for the child or vulnerable adult whilst he/she is in their charge.

Note to all members

TO GAIN ACCESS TO THE FLYING SITE, ALL MEMBERS MUST PROCEED TO THE GUARD ROOM TO SIGN IN, PRESENT THEIR MEMBERSHIP CARD TO OBTAIN A CAR AND PERSONAL PASS.

THESE PASSES MUST BE RETURNED TO THE GUARD ROOM AND COLLECT YOUR MEMBERSHIP CARD BEFORE LEAVING THE BARRACKS.
